Schoenberg litigated the Republic of Austria v. Altmann case, in which he sought return of six famous Klimt paintings to his client. After persuading the United States Supreme Court that Maria Altmann could sue Austria for return of the paintings, he agreed to arbitrate the dispute in Austria. In January 2006, the arbitration panel decided that the paintings, valued at over \$325 million, should be returned to Mrs. Altmann. In Budapest, Hungary, Memento Park is an open-air museum displaying 45 pieces of art from the Communist era between 1945 and 1989, which had previously been displayed throughout Hungary. By collecting the statues in a central, respectful location, Memento Park encourages visitors to think freely about dictatorship – and, by extension, democracy. Learn how Memento Park was formed, how visitors engage with these larger-than-life monuments to Communism, and what lessons we can learn from this unique space. Spiral of Injustice: a model created by the Wassmuth Center for Human Rights to illustrate the devolution of humanity whether discussing the Holocaust, other genocides, or contemporary acts of injustice. The model suggests that the “stages” of injustice (language, avoidance, discrimination, violence, and elimination) are in motion and employed as weapons for targeting “the other.”
